## RESULT NOTICE NO: \26 TIER-I DRIVER UNDER POST CODE-39/20 SDMC

- 1. The DSSSB vide its advertisement No.03/20 had advertised total-38 vacancies (UR-18, EWS-03, OBC-10, SC-05, ST-02 including ExSM-04, SP-02) for the Post of DRIVER under Post Code-39/20 in SDMC.
- 2. The Tier-I written examination (online mode) was conducted on **30.11.2021.**
- 3. The marks obtained by **1337 candidates** who have duly appeared in Tier-I written examination held on 30.11.2021 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 4. Based on the performance in the Tier-I written examination (online Mode), a total of 211 candidates, who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Trade Test, subject to correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Trade test separately.

5. Reserved Category candidates of EWS/OBC/SC/ST/ExSM/SP categories who have obtained marks above or equal to the last shortlisted UR Candidate have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.

6. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Trade test does not entitle them any right over the post.

- 7. Further, all the candidates who have secured marks equal to the cut off marks in each category have been shortlisted for appearing in Trade test.
- 8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examination for UR Category Candidate is 40%, for OBC candidate is 35% and for SC/ST/PH Category Candidate is 30%. Exservicemen will be given 5% relaxation in their respective category subject to minimum of 30%.
- 9. The details of Trade test shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
- 10. The above shortlisting for Trade test examination for the post of **DRIVER** under Post Code-39/20 in SDMC will be subject to outcome of pending court cases, if any.
- 11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
