It is for information that if any candidate qualified in the above result is falling under the purview of investigation relating to FIR No. 4 of 2021 dated 17.11.2021 U/S 7, 7A prevention of corruption act, 1988, 420, 466, 468, 477, 120 B (IPC) & 8(3)(4) of the Haryana Public Examination (Prevention of unfair means) Act, 2021 in PS SVB, Panchkula, his/her candidature would be purely on provisional basis and subject to final outcome of the said case.

Where no post for any reserved category is available, the candidate applying as a candidate of that particular category have been considered as General category candidates, subject to the fulfillment of the candidates of all eligibility conditions (Except fee, as meant for general category candidates).
- 6. The viva-voce will tentatively be held in the second week of September, 2022.
