CORRIGENDUM - II (Advt. No. 02/2025)

Recruitment of Deputy Manager and Process Assistant Grade- I (Trainee)

Due to smaller number of applications received for the posts, it has been decided to amend the eligibility criteria for external and internal (BRBNMPL) candidates. Accordingly, in partial modification of the Advt. No. 02/2025, it has been decided to amend as under:

2(A) Deputy Manager - Printing Engineering Background (Post code 01)

For External Candidates:

Should have passed B. Tech/B.E. with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Printing Technology/ Printing Engineering. Applicants having qualification in allied branch/equivalent discipline other than specified above need not apply.

They should have at least two years post qualification experience of working in a Printing Industry of repute, preferably in a security printing organization.

For Internal Candidates (BRBNMPL):

Should have passed B. Tech. / B.E. in Printing Technology/Printing Engineering from a government recognized Institute / University and should have put in at least two years of service in the Company OR Should have passed Diploma in Printing from a government recognized Institute / University and should have put in at least ten years of service in the Company. Applicants having qualification in allied branch/equivalent discipline other than specified above need not apply.

2(B) Deputy Manager - Electrical Engineering Background (Post code 02)

For External Candidates:

Should have passed B. Tech/B.E./AMIE (Certificate issued by the Institute of Engineers, Kolkata) with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Electrical Engineering/Electrical and Electronics Engineering/Power Engineering. Applicants having qualification in allied branch/equivalent discipline other than specified above need not apply.

2(A) Deputy Manager - Printing Engineering Background (Post code 01)

For External Candidates:

Should have passed B. Tech/B.E. with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Printing Technology / Printing Engineering OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts. Applicants having qualification in allied branch other than specified above need not apply.

They should have at least two years post qualification experience of working in a Printing Industry of repute, preferably in a security printing organization.

For Internal Candidates (BRBNMPL)

Should have passed B. Tech. / B.E. in Printing Technology/ Printing Engineering branch in engineering from a government recognized Institute / University OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts and should have put in at least two years of service in the Company OR Should have passed Diploma in Printing from a government recognized Institute / University and should have put in at least ten years of service in the Company. Applicants having qualification in allied branch other than specified above need not apply.

2(B) Deputy Manager - Electrical Engineering Background (Post code 02)

For External Candidates:

Should have passed B. Tech/B.E./AMIE (Certificate issued by the Institute of Engineers, Kolkata) with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Electrical Engineering/ Electrical and Electronics Engineering/ Power Engineering OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts. Applicants having qualification in allied branch other than specified above need not apply.

They should have at least two years post qualification experience of working in a reputed Manufacturing Industry/ PSU in Electrical Division or Electrical Maintenance or HT/LT Substations, preferably (a) working with HT/LT Switchgears and troubleshooting in substations and (b) having knowledge of PLCs/Power Monitoring through SCADA software.

For Internal Candidates (BRBNMPL):

Should have passed B. Tech. / B.E. / AMIE (Certificate issued by the Institute of Engineers, Kolkata) in Electrical / Electrical and Electronics / Power Engineering from a government recognized Institute / University and should have put in at least two years of service in the Company OR Should have passed Diploma in Electrical / Electrical and Electronics from a government recognized Institute / University and should have put in at least ten years of service in the Company. Applicants having qualification in allied branch/equivalent discipline other than specified above need not apply.

2(C) Deputy Manager - Computer Science Engineering Background (Post code 03)

For External Candidates:

Should have passed B. Tech/B.E./AMIE (Certificate issued by the Institute of Engineers, Kolkata) with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Computer Science Engineering. Applicants having qualification in allied branch/equivalent discipline other than specified above need not apply.

They should have at least two years' post qualification experience of working in an Industry of repute in Software Development or Software Maintenance or Software upgradation in a CMMI level - 5 organization.

For Internal Candidates (BRBNMPL):

Should have passed B. Tech. / B.E. / AMIE (Certificate issued by the Institute of Engineers, Kolkata) in Computer Science Engineering from a government recognized Institute / University and should have put in at least two years of service in the Company OR Should have passed Diploma in Computer Science Engineering from a government recognized Institute / University and should have put in at least ten years of service in the Company. **Applicants** having qualification in allied branch/equivalent discipline other than specified above need not apply.

They should have at least two years post qualification experience of working in a reputed Manufacturing Industry/ PSU in Electrical Division or Electrical Maintenance or HT/LT Substations, preferably (a) working with HT/LT Switchgears and troubleshooting in substations and (b) having knowledge of PLCs/Power Monitoring through SCADA software.

For Internal Candidates (BRBNMPL)

Should have passed B. Tech. / B.E. / AMIE (Certificate issued by the Institute of Engineers, Kolkata) in Electrical / Electrical and Electronics / Power Engineering from a government recognized Institute / University OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts and should have put in at least two years of service in the Company OR Should have passed Diploma in Electrical / Electrical and Electronics from a government recognized Institute / University and should have put in at least ten years of service in the Company. Applicants having qualification in allied branch other than specified above need not apply.

2(C) Deputy Manager - Computer Science Engineering Background (Post code 03)

For External Candidates:

Should have passed B. Tech/B.E./AMIE (Certificate issued by the Institute of Engineers, Kolkata) with 60% marks in the aggregate (55% marks in the aggregate for SC/ST candidates) from a government recognized Institute /University in Computer Science Engineering OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts. Applicants having qualification in allied branch other than specified above need not apply.

They should have at least two years' post qualification experience of working in an Industry of repute in Software Development or Software Maintenance or Software upgradation in a CMMI level - 5 organization.

For Internal Candidates (BRBNMPL)

Should have passed B. Tech. / B.E. / AMIE (Certificate issued by the Institute of Engineers, Kolkata) in Computer Science Engineering from a government recognized Institute / University OR equivalent branch in engineering approved by AICTE for recruitment to non-teaching posts and should have put in at least two years of service in the Company OR Should have passed Diploma in Computer Science Engineering from a government recognized Institute / University and should have put in at least ten years of service in the Company. Applicants having qualification in allied branch other than specified above need not apply.

Note: The candidates applying under equivalent branch for the above posts should ensure their eligibility regarding equivalence of the engineering branch to Printing Technology / Printing Engineering/ Electrical Engineering/ Electrical and Electronics Engineering/ Power Engineering/ Computer Science Engineering as applicable and also required to produce documentary evidence regarding the equivalence of the engineering degree possessed by them from the Competent Authority at the time of interview, if selected. Decision of BRBNMPL with regard to equivalence of the branch will be final.

- 3. **PAYSCALE at para 5**: additional clause **5C** included as "Candidates presently in Central Government/undertaking, on selection and appointment, will be eligible for protection of pay as per the rules of the Company".
- 4. Accordingly, the last date of registration of online applications for the post of Deputy Manager and Process Assistant Grade I (Trainee) has been extended till 29/09/2025. All other terms and conditions shall remain unchanged as mentioned in the Advt. No. 02/2025 published on Company's website. Candidates satisfying the eligibility criteria who have already applied for the posts within the due date need not apply again and their candidature will be considered based on their application already submitted.
