### Public Notice

1 . In pursuance of the Hon'ble Supreme Court's order dated 27.02.2026 in Writ Petition (Civil) No. 901/2025, *Ajay Kumar & Ors. vs. DSSSB & Anr.*, online applications are hereby invited only from the applicants of the year 2009 (Post Code 90/09) for participation in the ongoing recruitment process against 606 vacancies for the post of Grade-II (GNCTDSS)/Assistant Section Officer in Services Department, advertised vide advertisement No. 01/2026 dated 20.02.2026 read with corrigendum No. 1/158022/2026 dated 26.05.2026 under Post Code- 804/26.

2. The interested applicants of year 2009 under Post Code- 90/09 are required to apply afresh for the post of Grade-II (GNCTDSS)/Assistant Section Officer advertised under Post Code 804/26. The applicants shall upload any one of the following documents pertaining to Post Code 90/09 while submitting the online application:

- (i) Copy of Application Form (Post Code 90/09); or
- (ii). Original Post Card (Acknowledgement – Post Code 90/09); or
- (iii). Tier-I Examination Admit Card (Post Code 90/09); or
- (iv). Tier-II Examination Admit Card (Post Code 90/09).

3. Online applications shall be submitted through a special link on the official website <https://dsssonline.nic.in> as per the following schedule:

**Opening of Special Link : 17.07.2026 (12:00 Noon)**

**Closing of Special Link : 17.08.2026 (05:00 PM)**

Failure to submit the application within the stipulated period shall be deemed as unwillingness to participate in the recruitment process, and no further opportunity or correspondence in this regard shall be entertained.

4. The eligibility of an applicant will cease for the post of Grade-II(GNCTDSS)/ASO under Post Code- 804/26, if he/she attains the age of 60 years, which is the age of superannuation in Government service, either at the time of filling up the application form or at any stage during the selection process till the time of appointment as per DoPT norms.

5. Any applicant who has never registered on the Online Application Registration System (OARS) is required to first register as a new user on the website <https://dsssonline.nic.in>. After successful registration, applicant is required to apply for the post of Grade-II(GNCTDSS)/ASO under Post Code 804/26 through the special link provided at the website [dsssonline.nic.in](https://dsssonline.nic.in). Applicants are advised to submit their online applications much before the closing date, i.e. **17.08.2026 up to 05:00 PM** to avoid any last-minute issues.

6. Applicants may refer User Guide available on DSSSB's website <https://dsssonline.nic.in> while submitting their online applications.

7. Applicants are hereby cautioned that the said special link is exclusively meant for applicants of year 2009 under Post Code 90/09 and the candidature is restricted only for 606 vacancies of Grade-II (GNCTDSS)/Assistant Section Officer in the Services Department, GNCT of Delhi. Such applicants shall not be eligible for consideration against the vacancies of Assistant Section Officer in the Delhi Pollution Control Committee (DPCC) and the Delhi Urban Shelter Improvement Board (DUSIB) advertised under Post Code 804/26.

8. Submission of any false claim, incorrect information, fabricated document or suppression of material facts shall render the applicant liable for cancellation of candidature for the Post Code -804/26 and debarment from future examinations conducted by DSSSB, in addition to any other action permissible under law.

9. Applicants of the year 2009 (Post Code 90/09) who are unable to submit their applications through the online special link may submit an offline application in the prescribed format (**Annexure-I**) along with any one of the documents specified in Paragraph 2 above at the DSSSB Helpdesk . The offline applications received after the prescribed date and time or without any of the prescribed supporting documents shall be summarily rejected. No correspondence in this regard shall be entertained.

The DSSSB Helpdesk shall remain functional during working hours on all working days **from 17.07.2026 (10:30 AM) to 17.08.2026 up to 07:00 PM.**

10. Only the applicants of year 2009 under Post Code- 90/09 shall be able to submit their applications through the said special link. The list of eligible applicant of 2009 under Post Code 90/09 is available on the website of DSSSB i.e. <https://dsssb.delhi.gov.in>.

11. Rest of the terms and conditions of Advt. No. 01/2026 will apply mutatis mutandis.

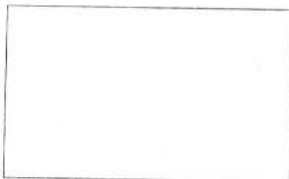
