Questions/Options/Keys**

The Computer Based Test (CBT-I) for the various Posts of Non Technical Popular Categories (Under Graduate) against CEN No 07/2025 was conducted from **07.05.2026 to 09.05.2026 & 13.06.2026 to 20.06.2026**. In order to enable candidates who appeared in the CBT-I to view their questions, responses and answer keys, a link has been provided on the websites of RRBs and <https://rrb.indianrailways.gov.in> (Common website of all RRBs) which will be active from **27.06.2026 at 19:00 hrs. to 05.07.2026 at 23:55 hrs.**

After viewing the details as above, objections if any, regarding the questions, options and keys can be raised by the candidates for which the time schedule, fee and procedure is given below:

1. TIME SCHEDULE :

2. FEE FOR RAISING OBJECTIONS :

The prescribed fee for raising objection is **Rs.50/- plus applicable Bank Service Charges per question**. In case the objection raised is found to be correct, the Fee Paid against such valid objections shall be refunded to the candidate after deduction of applicable Bank charges. The refund will be made to the account from where the candidate has made the online payment.
