- III. The Apprenticeship is period of 1 (One) Year purely on contractual basis. UGVCL shall no obligation to offer regular employment to Apprentices during and/or after the completion of the apprenticeship period.
- IV. Total tenure of apprenticeship training shall be one year from their date of joining. Apprenticeship training shall be co-terminated with completion of one-year duration and no further extension is permitted. Apprentices are not allowed to enroll/ undergo any regular course/job during their apprenticeship tenure.
- V. Candidate has to work in field offices any of under Mehsana Circle, Palanpur Circle, Himatnagar Circle and Sabarmati Circle of UGVCL during Apprenticeship engagement period.
- VI. Candidate shall not be eligible for Graduate Apprentice under BOAT Scheme on account of his/her:
 - (i) Undergone any Masters (post-graduation) course.
 - (ii) Awaiting the results of their final examination at the time of application.
 - (iii) Not completed the 18 years of age.
 - (iv) Undertaken any previous training as part of the apprenticeship program.
 - Have any work experience of one year or more after the attainment of prescribed qualifications.
- VII. Candidates with qualification acquired through Distance Learning Mode or Part Time Mode or Correspondence Mode shall not be considered.
- VIII. Engagement of selected candidates is subject to his/her being declared medically fit as per the requirement of Apprentices Act, 1961 and its subsequent amendments thereof.
- IX. The candidates who have been given grades in their result (graduation) shall have to submit a percentage as per certificate issued by their University/ Institute specifying percentage equivalent to the grades.
- X. If eligible candidates will be called for Interview. No travelling fare will be paid to any candidate for attending the interview.
- XI. Candidates are requested to apply only, if they are fulfilling requisite criteria. - **5.** Caste (SC/ST/SEBC/EWS) Certificate/Disability Certificate (if applicable).
- **6.** Identification Proof (Voter ID/ Pan Card/ Aadhar Card/Driving License etc).
- 7. Residential Address Proof (Electricity Bill/Telephone Bill/Ration Card/ Aadhar Card, etc).
